**Right to erasure/ right to be forgotten\***

Following your request, UBench will, without undue delay, erase your personal data if one of following grounds applies:

- The personal data is no longer necessary in relation to the purposes for which they were collected or otherwise processed
- You have withdrawn your consent on which the processing is based and there is no other legal ground for the processing
- You object to the processing and there are no overriding legitimate grounds for the processing or you object to the processing for the purpose of direct marketing
- Your personal data has been unlawfully processed
- Your personal data has to be erased for compliance with a legal obligation on behalf of UBench
- Your personal data has been collected in relation to the offer of services of the information society

**Right to restriction of processing\***

You would like to have the processing of your personal data restricted by UBench and one of the following applies:

- You contested the accuracy of your personal data and during the time UBench needs to verify the accuracy of the personal data, it will not process your personal data
- The processing is unlawful and you oppose to the erasure of your personal data and request the restriction of your personal data instead
- UBench no longer needs the personal data for the purpose of the processing, but you need them to file, exercise or defend a legal claim
- You objected to the processing of your personal data and during the verification whether the legitimate grounds of UBench override your legitimate grounds, UBench will not process your personal data

**Right to data portability of your personal data\***

- You wish to receive the personal data which you provided to UBench in a structured, commonly used and machine-readable format
- You want UBench to transmit your personal data to another processor/controller for the processing where:
  - The processing is based on your consent
  - The processing is carried out by automated means

**Warning:** This transmission by UBench will only take place where technically possible

**Right to object\***

The processing of your personal data (including profiling) occurs (i) for the performance of a task carried out for public interest (ii) in the scope of exercising a task of public authority granted to UBench (iii) on the basis of the legitimate interests of UBench or a third party and you wish to object to this processing due to a situation that applies specifically to you.
